



A Message from Rev. Rich

Hello Friends:

I am writing to you before the sun comes up on December 2, after our first good snow in a while. I hope you have all weathered this first batch. I am grateful, especially since my snowblower performed admirably!

There is much to say, but everyone is weary after these many months of anxiety and uncertainty. If we ever needed an Advent season and the coming of Christmas *to give us hope*, we certainly need it now. Hope is the force that keeps us going. But we are blessed, because in spite of what our culture has done to December, the essential meaning has always been there, like a discarded present hiding under the tree. It has been hidden with crumpled wrapping paper and almost accidentally thrown away (I actually saw this happen once!).

We sing a song about the name of Jesus (*"There's Something About That Name"*) which doesn't sound like Christmas, but His Name offers us something so special. Yeho-shuah (or more like *Joshua* in our modern language), the actual name of Jesus, means basically that *"God is the Rescuer."* Now this might not make sense. We might feel that we are *not lost* or in trouble, and therefore *do not need* to be rescued. Our beliefs about our faith in fact go in so many directions. We might see ourselves as not really needing any assistance at all. We might be quite fortunate (and if you are reading this, you already are); but our society and all the world is clearly an angry, broken group. We have damaged our own planet, treating it as disposable and exploitable. Sure, *cut down that rain forest, because someone will cash in on it!* Once again we are seeing that in Australia, it is 116 degrees and on fire. There is no good news in this.

But just like our ancestors in Faith, we are asked to hope, and to trust God. We are also asked to listen to words and warnings from long ago that still ring true. We are asked to listen because God is still speaking. And we have to get it out of our minds that Advent and Christmas only have to do with the past. This is not a historical re-enactment. We sing of the coming of a Messiah. But my goodness, we need him now more than ever. We need the world he will bring. And the promise is that *it will happen*. Something beyond our ability to imagine will become real in our world. The world and all of us will be redeemed and restored. We will in fact be rescued. That does not mean we are to sit back and wait. We cannot, because too many people are losing hope. This is where we are asked to actively shine that light, and to love others anyway, because we know how the story will end. Like we learned in the Sermon on the Mount back in August and September, we are to import God's future to our trembling present. We can do this. I will do all that I can to share this understanding for us. It matters what we believe.

I cannot predict how this month of December will unfold. But we are preparing for the disappointment of not being able to hold candles while singing Silent Night as usual. We are working together to create something beautiful for people to enjoy, something that will give us hope. Pray for us as we do the best we can with what we are facing. Better days will come. Please stay safe, wear your mask, wash your hands, and avoid close contact with people who do not live with you. We can do these things.

May God bless and keep you, and all the world.

Living through a pandemic is incredibly difficult, and is harder for some more than others. Even if you have suffered your own losses — a job, ability to travel, in-person contact with loved ones or worse — letting others know that they are on your mind and in your heart can be healing for you both. Getting through tough times together is far easier than alone. Make sure the people you care about know you’re there for them and they’ll likely be there for you, too.

Dear Friends,

We would like to stress the importance of non-employees being in the pre-school area during school hours.

The employees of the Apple Tree Preschool, Rev. Rich and Secretary, Gale Lane are the only people that have been approved by the Ohio State Department of Job and Family Services to be in and around the preschool during their operating hours (Tuesday thru Thursday from 9am to 1pm). These employees are required to have their temperature taken and hands sanitized before entering the preschool areas.

The children deserve to be safe and well cared for at all times. One of the children's care provider's most important responsibilities is keeping the children safe from harm. One way your provider does this is by making sure that all adults with access to the children have had a comprehensive background check.

The following list has more details about the specific checks that are required.

1. An FBI fingerprint check
2. A search of the National Crime Information Center's National Sex Offender Registry
3. A search of the following registries, repositories, and databases in the state where the child care staff member lives and each state where the staff member has lived in the past 5 years:
 - State criminal registry or repository (fingerprints are required in the state where the staff member currently lives, and optional in other states)
 - State sex offender registry or repository
 - State-based child abuse and neglect registry and database

They are also required to have a medical form filled out by their Health Care Provider certifying the following:

- Physically fit for employment at a facility caring for children.
- Immunized against Diphtheria/Tetanus/Pertussis (Tdap)
- Immunized against Measles, Mumps and Rubella (MMR)

When these official rules are NOT followed, our Apple Tree Preschool is in risk of being shut down.

Thank you to everyone for being respectful of the Apple Tree Preschool official rules.
